

1 Overall quality at a glance

The reported resolution of this entry is 2.20 Å.

2 Entry composition (i)


There are 4 unique types of molecules in this entry. The entry contains 13840 atoms, of which 5 are hydrogens and 0 are deuterium.



5.2 Close contacts (i)

The Symm-Clashes column gives symmetry related clashes, in the same way as for the Clashes column.
