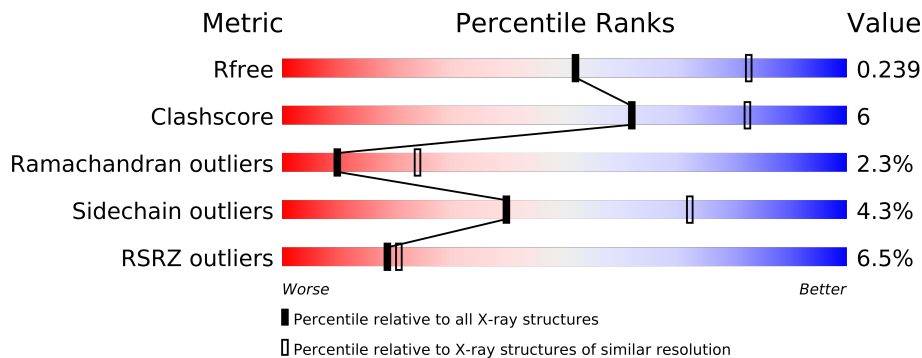

# 1 Overall quality at a glance

The reported resolution of this entry is 2.70 Å.

## 2 Entry composition i

There are 3 unique types of molecules in this entry. The entry contains 2708 atoms, of which 0 are hydrogen and 0 are deuterium.

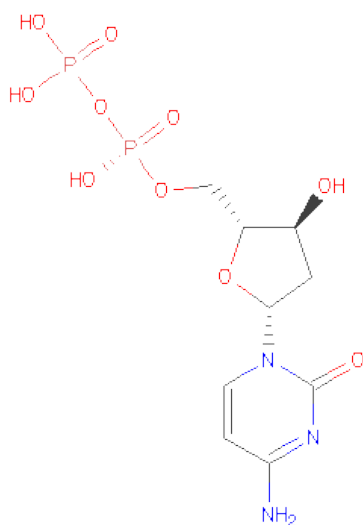

## 5.2 Close contacts ⓘ

In the following table, the Non-H and H(model) columns list the number of non-hydrogen atoms and hydrogen atoms in the chain respectively.
