

# 1 Overall quality at a glance

The reported resolution of this entry is 1.30 Å.

Percentile scores (ranging between 0-100) for global validation metrics of the entry are shown in the following graphic. The table shows the number of entries on which the scores are based.

## 2 Entry composition i

There are 3 unique types of molecules in this entry. The entry contains 6499 atoms, of which 3467 are hydrogens and 0 are deuterium.

In the tables below, the ZeroOcc column contains the number of atoms modelled with zero occupancy, the AltConf column contains the number of residues with at least one atom in alternate conformation and the Trace column contains the number of residues modelled with at most 2 atoms.

- Molecule 1 is a protein called uncharacterized protein 201phi2-1p060.



### 5.2 Close contacts
