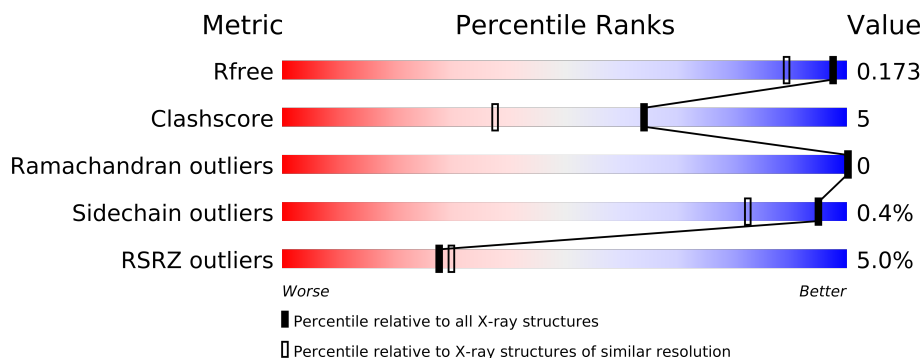

1 Overall quality at a glance


The reported resolution of this entry is 1.35 Å.

2 Entry composition i

There are 6 unique types of molecules in this entry. The entry contains 2489 atoms, of which 0 are hydrogen and 0 are deuterium.

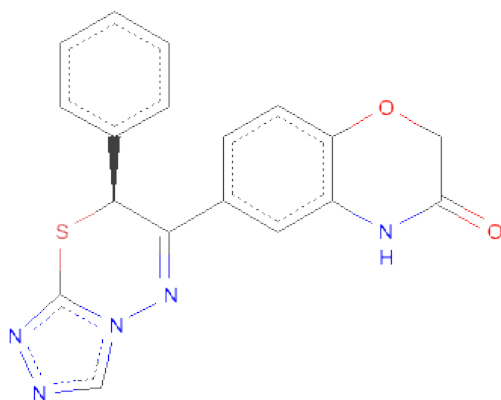

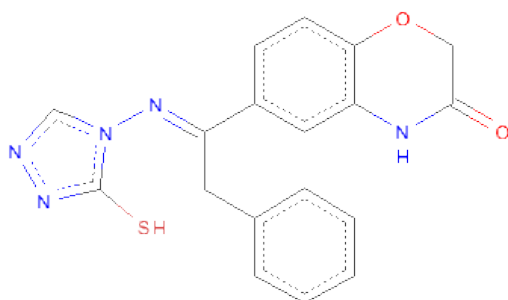

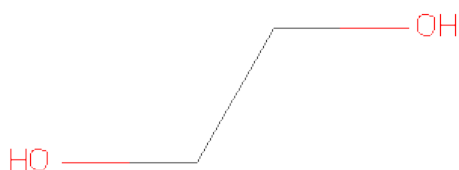

5 Model quality

5.1 Standard geometry

Bond lengths and bond angles in the following residue types are not validated in this section: LD2, K, LD1, EDO

The Z score for a bond length (or angle) is the number of standard deviations the observed value is removed from the expected value. A bond length (or angle) with $|Z| > 5$ is considered an outlier worth inspection. RMSZ is the root-mean-square of all Z scores of the bond lengths (or angles).

5.2 Close contacts

In the following table, the Non-H and H(model) columns list the number of non-hydrogen atoms and hydrogen atoms in the chain respectively. The H(added) column lists the number of hydrogens added by MolProbity. The Clashes column lists the number of clashes within the asymmetric unit, and the number in parentheses is this value normalized per 1000 atoms of the molecule in the chain. The Symm-Clashes column gives symmetry related clashes, in the same way as for the Clashes column.

Clashscore is defined as the number of clashes calculated for the entry per 1000 atoms (including hydrogens) of the entry. The overall clashscore for this entry is 5.

Of 5 ligands modelled in this entry, 1 is monoatomic - leaving 4 for Mogul analysis.

The Link column lists molecule types, if any, to which the group is linked. The Z score for a bond length (or angle) is the number of standard deviations the observed value is removed from the expected value. A bond length (or angle) with $|Z| > 2$ is considered an outlier worth inspection. RMSZ is the root-mean-square of all Z scores of the bond lengths (or angles).
