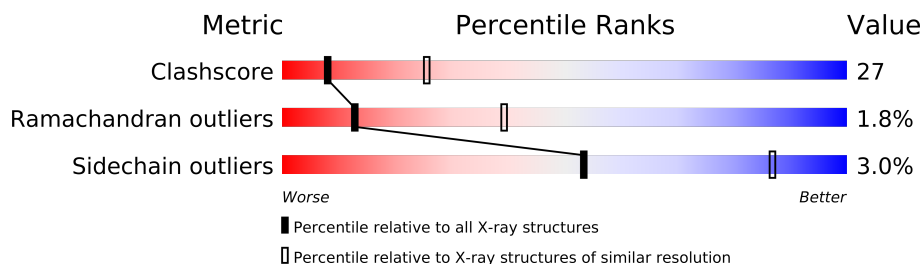

1 Overall quality at a glance

The reported resolution of this entry is 2.80 Å.

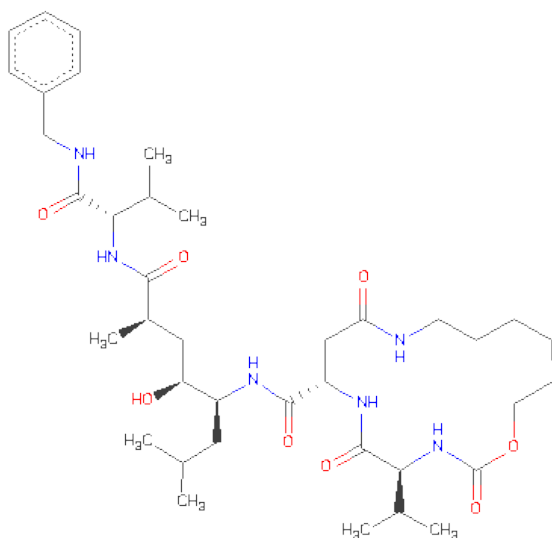
There are 2 unique types of molecules in this entry. The entry contains 3105 atoms, of which 0 are hydrogen and 0 are deuterium.
