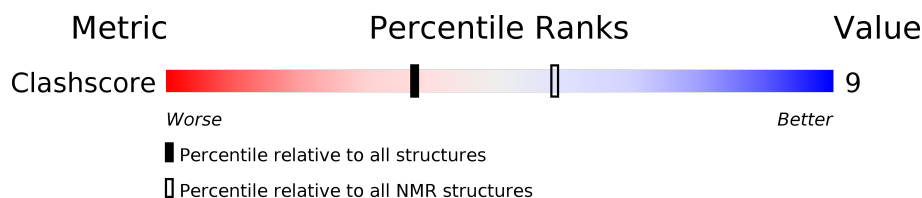
# 1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

*SOLUTION NMR*

The overall completeness of chemical shifts assignment was not calculated.

Percentile scores (ranging between 0-100) for global validation metrics of the entry are shown in the following graphic. The table shows the number of entries on which the scores are based.

The table below summarises the geometric issues observed across the polymeric chains and their fit to the experimental data. The red, orange, yellow and green segments indicate the fraction of residues that contain outliers for  $\geq 3$ , 2, 1 and 0 types of geometric quality criteria. A cyan segment indicates the fraction of residues that are not part of the well-defined cores, and a grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions  $\leq 5\%$

## 2 Ensemble composition and analysis ⓘ

This entry contains 5 models. This entry does not contain polypeptide chains, therefore identification of well-defined residues and clustering analysis are not possible. All residues are included in the validation scores.

### 3 Entry composition [i](#)

There is only 1 type of molecule in this entry. The entry contains 383 atoms, of which 133 are hydrogens and 0 are deuteriums.

- Molecule 1 is DNA/RNA hybrid called 5'-R(\*GP\*GP\*AP\*CP)D(\*TP\*TP\*CP\*GP\*(GFL)P\*(TAF)P\*(CFL)P\*(CFL))-3'.

## 4 Residue-property plots [i](#)

### 4.1 Average score per residue in the NMR ensemble

These plots are provided for all protein, RNA and DNA chains in the entry. The first graphic is the same as shown in the summary in section 1 of this report. The second graphic shows the sequence where residues are colour-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. Stretches of 2 or more consecutive residues without any outliers are shown as green connectors. Residues which are classified as ill-defined in the NMR ensemble, are shown in cyan with an underline colour-coded according to the previous scheme. Residues which were present in the experimental sample, but not modelled in the final structure are shown in grey.

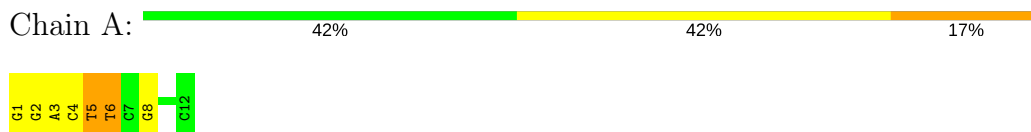

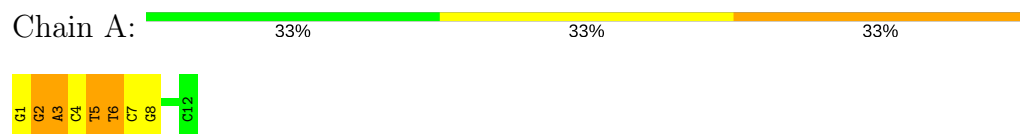

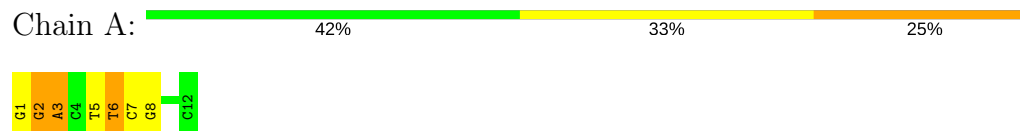

## 5 Refinement protocol and experimental data overview ⓘ

The models were refined using the following method: *Distance geometry, simulated annealing*.

Of the 5 calculated structures, 5 were deposited, based on the following criterion: *RMSD FROM AVERAGE LOWER THAN 0.7 ANGSTROM*.

## 6 Model quality i

### 6.1 Standard geometry i

Bond lengths and bond angles in the following residue types are not validated in this section: CFL, TAF, GFL

The Z score for a bond length (or angle) is the number of standard deviations the observed value is removed from the expected value. A bond length (or angle) with  $|Z| > 5$  is considered an outlier worth inspection. RMSZ is the (average) root-mean-square of all Z scores of the bond lengths (or angles).
