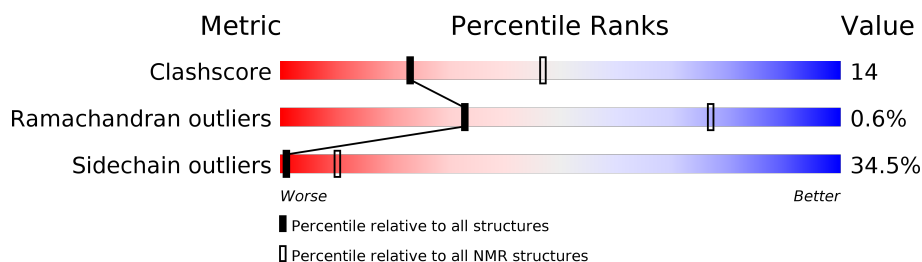
1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

SOLUTION NMR

The overall completeness of chemical shifts assignment is 87%.

Percentile scores (ranging between 0-100) for global validation metrics of the entry are shown in the following graphic. The table shows the number of entries on which the scores are based.

The table below summarises the geometric issues observed across the polymeric chains and their fit to the experimental data. The red, orange, yellow and green segments indicate the fraction of residues that contain outliers for ≥ 3 , 2, 1 and 0 types of geometric quality criteria. A cyan segment indicates the fraction of residues that are not part of the well-defined cores, and a grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$

2 Ensemble composition and analysis

This entry contains 10 models. Model 7 is the overall representative, medoid model (most similar to other models). The authors have identified model 1 as representative, based on the following criterion: *closest to the average*.

The following residues are included in the computation of the global validation metrics.

Ill-defined regions of proteins are excluded from the global statistics.

Ligands and non-protein polymers are included in the analysis.

The models can be grouped into 2 clusters and 1 single-model cluster was found.

3 Entry composition

There is only 1 type of molecule in this entry. The entry contains 921 atoms, of which 460 are hydrogens and 0 are deuteriums.

- Molecule 1 is a protein called Bifunctional membrane-associated penicillin-binding protein 1A/1B ponA2.

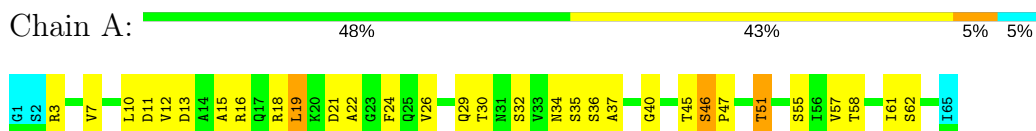

4 Residue-property plots [i](#)

4.1 Average score per residue in the NMR ensemble

These plots are provided for all protein, RNA and DNA chains in the entry. The first graphic is the same as shown in the summary in section 1 of this report. The second graphic shows the sequence where residues are colour-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. Stretches of 2 or more consecutive residues without any outliers are shown as green connectors. Residues which are classified as ill-defined in the NMR ensemble, are shown in cyan with an underline colour-coded according to the previous scheme. Residues which were present in the experimental sample, but not modelled in the final structure are shown in grey.

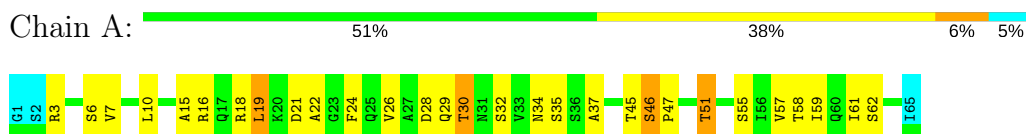

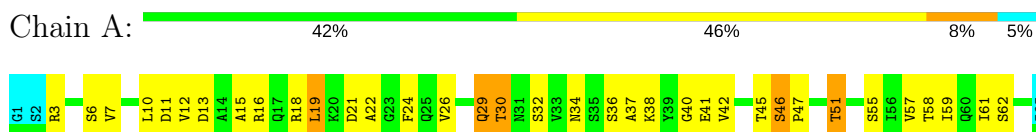

- Molecule 1: Bifunctional membrane-associated penicillin-binding protein 1A/1B ponA2



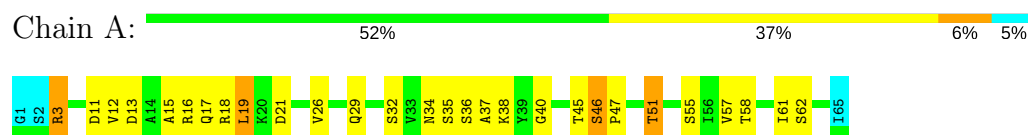

- Molecule 1: Bifunctional membrane-associated penicillin-binding protein 1A/1B ponA2



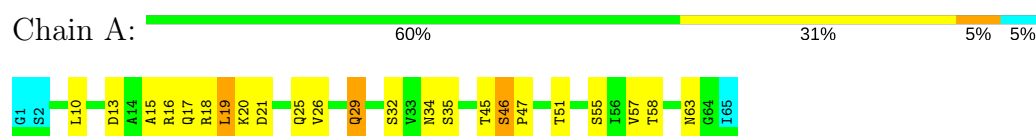

- Molecule 1: Bifunctional membrane-associated penicillin-binding protein 1A/1B ponA2



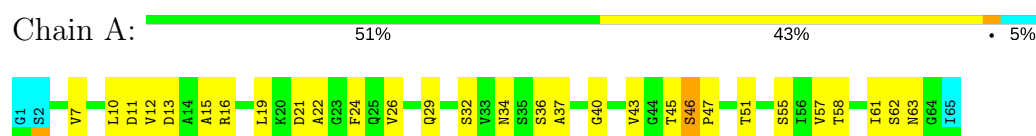

- Molecule 1: Bifunctional membrane-associated penicillin-binding protein 1A/1B ponA2



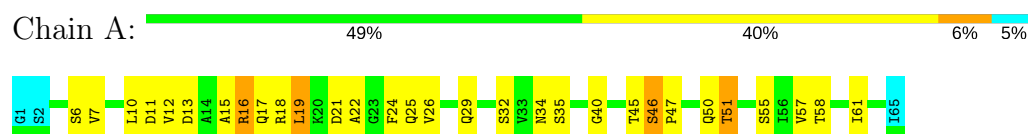

- Molecule 1: Bifunctional membrane-associated penicillin-binding protein 1A/1B ponA2



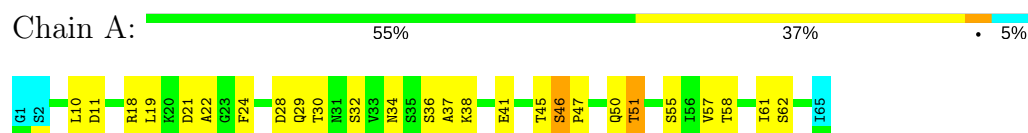

- Molecule 1: Bifunctional membrane-associated penicillin-binding protein 1A/1B ponA2



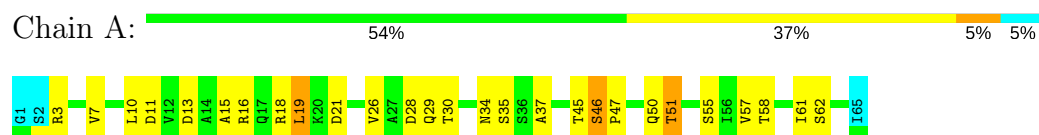

- Molecule 1: Bifunctional membrane-associated penicillin-binding protein 1A/1B ponA2



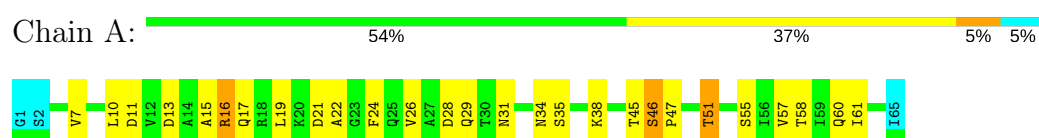

- Molecule 1: Bifunctional membrane-associated penicillin-binding protein 1A/1B ponA2



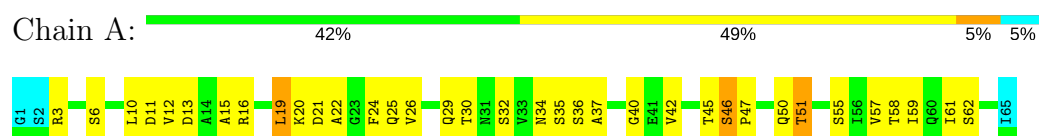

5 Refinement protocol and experimental data overview

The overall completeness is 87%, i.e. 592 atoms were assigned a chemical shift out of a possible 682. 8 out of 10 assigned methyl groups (LEU and VAL) were assigned stereospecifically.

7.1.5 Random Coil Index (RCI) plots [i](#)

The image below reports *random coil index* values for the protein chains in the structure. The height of each bar gives a probability of a given residue to be disordered, as predicted from the available chemical shifts and the amino acid sequence. A value above 0.2 is an indication of significant predicted disorder. The colour of the bar shows whether the residue is in the well-defined core (black) or in the ill-defined residue ranges (cyan), as described in section 2 on ensemble composition.
