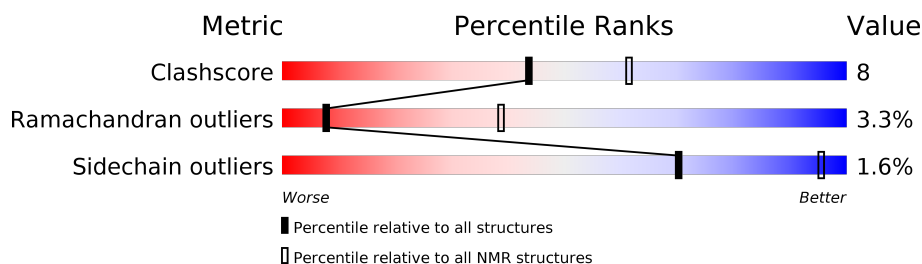
# 1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

*SOLUTION NMR*

The overall completeness of chemical shifts assignment is 47%.

Percentile scores (ranging between 0-100) for global validation metrics of the entry are shown in the following graphic. The table shows the number of entries on which the scores are based.

The table below summarises the geometric issues observed across the polymeric chains and their fit to the experimental data. The red, orange, yellow and green segments indicate the fraction of residues that contain outliers for  $\geq 3$ , 2, 1 and 0 types of geometric quality criteria. A cyan segment indicates the fraction of residues that are not part of the well-defined cores, and a grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions  $\leq 5\%$

## 2 Ensemble composition and analysis ⓘ

This entry contains 20 models. Model 13 is the overall representative, medoid model (most similar to other models). The authors have identified model 1 as representative, based on the following criterion: *closest to the average*.

The following residues are included in the computation of the global validation metrics.

Well-defined (core) protein residues

Ill-defined regions of proteins are excluded from the global statistics.

Ligands and non-protein polymers are included in the analysis.

The models can be grouped into 5 clusters. No single-model clusters were found.

### 3 Entry composition [i](#)

There is only 1 type of molecule in this entry. The entry contains 395 atoms, of which 180 are hydrogens and 0 are deuteriums.

- Molecule 1 is a protein called pheromone Ep-1.

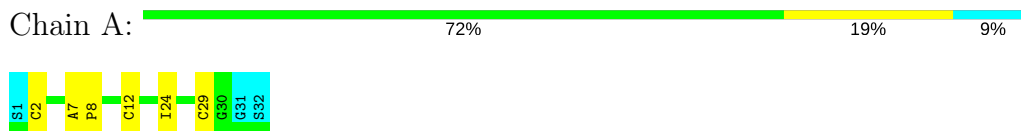

## 4 Residue-property plots [i](#)

### 4.1 Average score per residue in the NMR ensemble

These plots are provided for all protein, RNA and DNA chains in the entry. The first graphic is the same as shown in the summary in section 1 of this report. The second graphic shows the sequence where residues are colour-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. Stretches of 2 or more consecutive residues without any outliers are shown as green connectors. Residues which are classified as ill-defined in the NMR ensemble, are shown in cyan with an underline colour-coded according to the previous scheme. Residues which were present in the experimental sample, but not modelled in the final structure are shown in grey.

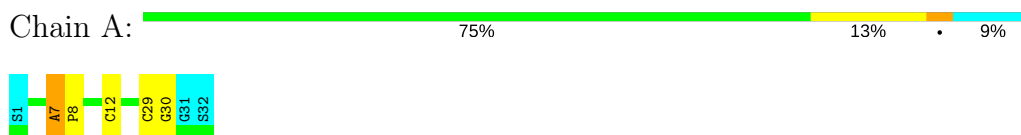
- Molecule 1: pheromone Ep-1

## 5 Refinement protocol and experimental data overview

The models were refined using the following method: *torsion angle dynamics, simulated annealing*.

Of the 30 calculated structures, 20 were deposited, based on the following criterion: *structures with the lowest energy*.

In the following table, the Non-H and H(model) columns list the number of non-hydrogen atoms and hydrogen atoms in each chain respectively. The H(added) column lists the number of hydrogen atoms added and optimized by MolProbity. The Clashes column lists the number of clashes averaged over the ensemble.

The all-atom clashscore is defined as the number of clashes found per 1000 atoms (including hydrogen atoms). The all-atom clashscore for this structure is 8.

## 7 Chemical shift validation

The completeness of assignment taking into account all chemical shift lists is 47% for the well-defined parts and 46% for the entire structure.

#### 7.1.2 Chemical shift referencing

No chemical shift referencing corrections were calculated (not enough data).

#### 7.1.3 Completeness of resonance assignments

The following table shows the completeness of the chemical shift assignments for the well-defined regions of the structure. The overall completeness is 47%, i.e. 134 atoms were assigned a chemical shift out of a possible 284. 0 out of 2 assigned methyl groups (LEU and VAL) were assigned stereospecifically.

### 7.1.4 Statistically unusual chemical shifts [i](#)

The following table lists the statistically unusual chemical shifts. These are statistical measures, and large deviations from the mean do not necessarily imply incorrect assignments. Molecules containing paramagnetic centres or hemes are expected to give rise to anomalous chemical shifts.

### 7.1.5 Random Coil Index (RCI) plots [i](#)

The image below reports *random coil index* values for the protein chains in the structure. The height of each bar gives a probability of a given residue to be disordered, as predicted from the available chemical shifts and the amino acid sequence. A value above 0.2 is an indication of significant predicted disorder. The colour of the bar shows whether the residue is in the well-defined core (black) or in the ill-defined residue ranges (cyan), as described in section 2 on ensemble composition.
