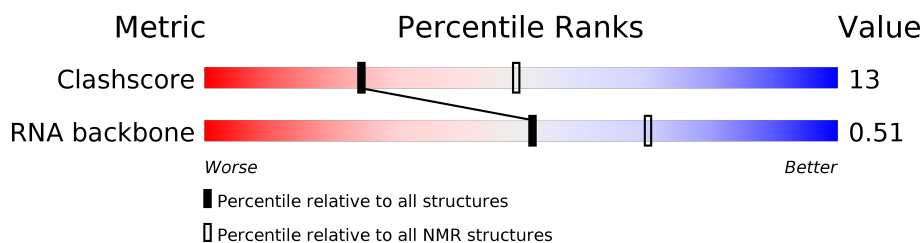
1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

SOLUTION NMR

The overall completeness of chemical shifts assignment is 69%.

Percentile scores (ranging between 0-100) for global validation metrics of the entry are shown in the following graphic. The table shows the number of entries on which the scores are based.

The table below summarises the geometric issues observed across the polymeric chains and their fit to the experimental data. The red, orange, yellow and green segments indicate the fraction of residues that contain outliers for ≥ 3 , 2, 1 and 0 types of geometric quality criteria. A cyan segment indicates the fraction of residues that are not part of the well-defined cores, and a grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$

2 Ensemble composition and analysis ⓘ

This entry contains 10 models. This entry does not contain polypeptide chains, therefore identification of well-defined residues and clustering analysis are not possible. All residues are included in the validation scores.

3 Entry composition [i](#)

There is only 1 type of molecule in this entry. The entry contains 550 atoms, of which 186 are hydrogens and 0 are deuteriums.

- Molecule 1 is a RNA chain called RNA (5'-R(*GP*GP*AP*AP*UP*CP*GP*AP*AP*AP*GP*AP*UP*GP*UP*CP*C)-3').

4 Residue-property plots [i](#)

4.1 Average score per residue in the NMR ensemble

These plots are provided for all protein, RNA and DNA chains in the entry. The first graphic is the same as shown in the summary in section 1 of this report. The second graphic shows the sequence where residues are colour-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. Stretches of 2 or more consecutive residues without any outliers are shown as green connectors. Residues which are classified as ill-defined in the NMR ensemble, are shown in cyan with an underline colour-coded according to the previous scheme. Residues which were present in the experimental sample, but not modelled in the final structure are shown in grey.

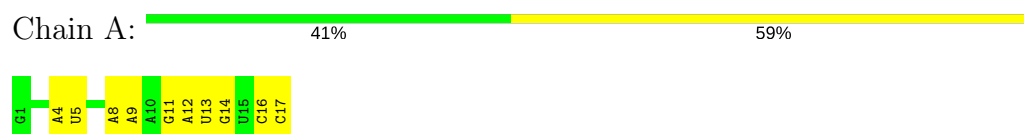

5 Refinement protocol and experimental data overview

The models were refined using the following method: *torsion angle dynamics, simulated annealing*.

Of the 10 calculated structures, 10 were deposited, based on the following criterion: *all calculated structures submitted*.

The all-atom clashscore is defined as the number of clashes found per 1000 atoms (including hydrogen atoms). The all-atom clashscore for this structure is 13.

7.1.2 Chemical shift referencing

No chemical shift referencing corrections were calculated (not enough data).

7.1.3 Completeness of resonance assignments

The following table shows the completeness of the chemical shift assignments for the well-defined regions of the structure. The overall completeness is 69%, i.e. 221 atoms were assigned a chemical shift out of a possible 322. 0 out of 0 assigned methyl groups (LEU and VAL) were assigned stereospecifically.
