
1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

SOLUTION NMR

The overall completeness of chemical shifts assignment is 51%.

Percentile scores (ranging between 0-100) for global validation metrics of the entry are shown in the following graphic. The table shows the number of entries on which the scores are based.

The table below summarises the geometric issues observed across the polymeric chains and their fit to the experimental data. The red, orange, yellow and green segments indicate the fraction of residues that contain outliers for ≥ 3 , 2, 1 and 0 types of geometric quality criteria. A cyan segment indicates the fraction of residues that are not part of the well-defined cores, and a grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$

2 Ensemble composition and analysis

This entry contains 10 models. Model 1 is the overall representative, medoid model (most similar to other models).

The following residues are included in the computation of the global validation metrics.

Ill-defined regions of proteins are excluded from the global statistics.

Ligands and non-protein polymers are included in the analysis.

The models can be grouped into 2 clusters and 5 single-model clusters were found.

3 Entry composition [i](#)

There is only 1 type of molecule in this entry. The entry contains 249 atoms, of which 133 are hydrogens and 0 are deuteriums.

- Molecule 1 is a protein called Estrogen receptor-binding stapled peptide SP6.



4 Residue-property plots

4.1 Average score per residue in the NMR ensemble

These plots are provided for all protein, RNA and DNA chains in the entry. The first graphic is the same as shown in the summary in section 1 of this report. The second graphic shows the sequence where residues are colour-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. Stretches of 2 or more consecutive residues without any outliers are shown as green connectors. Residues which are classified as ill-defined in the NMR ensemble, are shown in cyan with an underline colour-coded according to the previous scheme. Residues which were present in the experimental sample, but not modelled in the final structure are shown in grey.


- Molecule 1: Estrogen receptor-binding stapled peptide SP6

5.1 Too-close contacts

The H(added) column lists the number of hydrogen atoms added and optimized by MolProbity. The Clashes column lists the number of clashes averaged over the ensemble.

5.3 Non-standard residues in protein, DNA, RNA chains [i](#)

In the following table, the Counts columns list the number of bonds for which Mogul statistics could be retrieved, the number of bonds that are observed in the model and the number of bonds that are defined in the chemical component dictionary. The Link column lists molecule types,

if any, to which the group is linked. The Z score for a bond length is the number of standard deviations the observed value is removed from the expected value. A bond length with $|Z| > 2$ is considered an outlier worth inspection. RMSZ is the average root-mean-square of all Z scores of the bond lengths.

In the following table, the Counts columns list the number of angles for which Mogul statistics could be retrieved, the number of angles that are observed in the model and the number of angles that are defined in the chemical component dictionary. The Link column lists molecule types, if any, to which the group is linked. The Z score for a bond angle is the number of standard deviations the observed value is removed from the expected value. A bond angle with $|Z| > 2$ is considered an outlier worth inspection. RMSZ is the average root-mean-square of all Z scores of the bond angles.

6 Chemical shift validation

The completeness of assignment taking into account all chemical shift lists is 51% for the well-defined parts and 51% for the entire structure.

6.1.2 Chemical shift referencing

No chemical shift referencing corrections were calculated (not enough data).

6.1.3 Completeness of resonance assignments

The following table shows the completeness of the chemical shift assignments for the well-defined regions of the structure. The overall completeness is 51%, i.e. 67 atoms were assigned a chemical shift out of a possible 131. 0 out of 3 assigned methyl groups (LEU and VAL) were assigned stereospecifically.

6.1.4 Statistically unusual chemical shifts

There are no statistically unusual chemical shifts.

6.1.5 Random Coil Index (RCI) plots [i](#)

The image below reports *random coil index* values for the protein chains in the structure. The height of each bar gives a probability of a given residue to be disordered, as predicted from the available chemical shifts and the amino acid sequence. A value above 0.2 is an indication of significant predicted disorder. The colour of the bar shows whether the residue is in the well-defined core (black) or in the ill-defined residue ranges (cyan), as described in section 2 on ensemble composition.
